




### **Introduction to Shimnit India**



## Introduction to High Security Registration Plates (HSRP)

#### What?

High Security Registration Plate (HSRP) is a standardised vehicle license plate mandated by the Government of India for all motor vehicles under Rule 50 of the Central Motor Vehicles Rules (CMVR), 1989 way back in the year 2001.

# Why?

HSRPs enhance vehicle identification and ensures issuance control of vehicle number plate, which reduces illegal activities like theft and cloning, improves road safety, and are integrated with the VAHAN system for efficient vehicle tracking.

### When?

On December 6, 2018, a mandate required vehicle manufacturers (OEMs) to equip all new vehicles produced from April 1, 2019, with pre-fitted HSRPs. The State Transport Department oversees the transition for vehicles made before this date to ensure uniform vehicle security nationwide.







As per the Rule 50 of CMVR, 1989, states the mandatory fixation of the third registration mark or Third Licence Plate (TLP) on the inside of the vehicle's windshield, positioned at the top left corner. This serves the purpose of double secure identification mark of a vehicle.

# **Application:**

These stickers are applicable to BS VI vehicles.

# Compliance:

Vehicles complying with BS VI emission norms shall have a 1 cm green strip at the top in the third registration plate.


